**Subject: Subject: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Withdrawal / Non-implementation of Facilities Agreement**

Dear Sir/Madam,

Pursuant to Regulation 30 read with Para B of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”), we wish to inform you that the Company had earlier, vide its intimation dated **March 04, 2025**, informed the Stock Exchanges regarding the execution of a **Facilities Agreement** with *Marya Frozen Agro Food Products Private Limited* (“Marya”) for availing facilities for slaughtering, chilling, processing, freezing, and packing of frozen Halal boneless buffalo meat.

We would like to inform you that the said agreement **was not implemented and has not come into effect** due to **non-agreement of proposed terms and conditions** by *Marya Frozen Agro Food Products Private Limited*. The Company has now decided to **withdraw and discontinue** the said proposed arrangement with *Marya Frozen Agro Food Products Private Limited*.

Accordingly, the earlier intimation regarding the said Facilities Agreement **now stands withdrawn**, as the agreement was **never acted upon nor operationalized**.

At present, the Company is **engaged only in purchase transactions of packed frozen buffalo meat**, and **no slaughtering, chilling, processing, or facility-based activities are being carried out**.

There is **no impact on the existing business operations** of the Company due to the withdrawal of the said agreement, as the Company continues its regular **purchase activities from the Marya Frozen Agro Food Products Private Limited**, as mutually decided between both parties.

This disclosure is being made in the interest of transparency and in compliance with the applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular No. **SEBI/HO/CFD/CFDPoD1/P/CIR/2023/123** dated **July 13, 2023**.
