In order to gradually achieve compliance with the MPS norms, the promoters of the Company undertook a sale of 99,60,000 equity shares (representing 1.98% of the total share capital) through the Open Market Sale method, as permitted under Point 3, Sl. No. 7(i) of SEBI Circular No. SEBI/HO/CFD/PoD2/P/CIR/2023/18 dated February 03, 2023. The said sale took place between June 10, 2025 and June 16, 2025 3. After abovementioned sale of shares, Shareholding of Promoters is 81.63 and Public Holding is 18.37 and 4. The minimum public shareholding requirement will be completed by the company within the given time of 3 years and will be informed to the Stock Exchanges in due course.
